

EXCLUSIVE: I Have Ghislaine Maxwell's Security Score, Custody Level, Transfer Code, and Sex Offender Waiver

I have reviewed an electronic file that includes some of the information Senator Whitehouse is demanding from the Bureau of Prisons.

Today, we learned from Adam Klasfeld at All Rise News that Senator Whitehouse (D RI) has penned a letter to the Director of the Federal Bureau of Prisons William Marshall demanding answers surrounding the redesignation and transfer of convict serial sex trafficker Ghislaine Maxwell to a minimum security facility.

Ms. Maxwell was transferred without explanation and in possible violation of standard Bureau policy. Against the backdrop of the political scandal arising from President Trump's relationship with Jeffrey Epstein, Ms. Maxwell's abrupt transfer raises questions about whether she has been given special treatment in exchange for political favors.

I have Ghislaine Maxwell's security score, custody level, transfer code, public safety factor, and sex offender waiver.

NAME . . . : MAXWELL, GHISLAINE

PUB SFTY: SEX OFFN

As part of his inquiry, Senator Whitehouse is demanding documents from the BOP involving:

1. *Deputy Attorney General Todd Blanche, any member of the Office of the Deputy Attorney General, or any other Department of Justice official not employed by the Bureau of Prisons.*
2. *Requests, and the disposition of such requests, for the redesignation and transfer of Maxwell.*
3. *Requests, and the disposition of such requests, for waiver of any Public Safety Facto associated with Ms. Maxwell's designation or redesignation.*
4. *Any decision to waive, as applied to Ms. Maxwell, the standard procedures for submissions of an inmate transfer request as detailed in Chapter 7 of the Bureau's Program Statement 5100.08, Inmate Security Designation and Custody Classification.*
5. ***Any transfer codes associated with Ms. Maxwell's redesignation and transfer***
6. ***Ms. Maxwell's security point score; custody level; and any requests for, applications of, and reasons for Management Variables associated with Ms. Maxwell's placement as of June 1, 2025.***

7. Ms. Maxwell's security point score; custody level; and any requests for, applications of, and reasons for Management Variables associated with Ms. Maxwell's placement as of August 1, 2025.

According to a report I have reviewed provided by a source who wishes to remain anonymous, I can reveal some of the information requested in numbers 5 - 7 of Senator Whitehouse's letter.

According to a source, Maxwell's transfer code is 308 - Lesser Security Transfer. This transfer code is normally reserved for inmates whose point total has come down, but sex offenders are never transferred to minimum security facilities.

Her security point score is 27. This total is comprised of a 20 point custody score and 7 point base score. Here is her 20 point custody score:

Then she has a 7 point base score which is the highest severity because of her sex offender status.

(B) BASE SCORING

SEVERITY.....: (7) GREATEST

CRIM HIST SCORE: (00) 0 POINTS

VIOLENCE.....: (0) NONE

AGE CATEGORY...: (0) 55 AND OVER

Despite her score of 27 resulting in a MINIMUM security level, BOP policy does not allow people with a sex offender PSF (Public Safety Factor) to serve their sentences minimum security facilities. Someone has to waive the PSF to make that move.

NAME....: MAXWELL, GHISLAINE

MGTV: PSF WAV

PUB SFTY: SEX OFFN

MVED: N/A

As you can see here, her Management Variable (MGTV) says "PSF WAV", and her PS (Public Safety Factor) is "SEX OFFN" (sex offender.) This indicates she is a threat to the public because of her sex offender status, and her Management Variable of PSF WA indicates her sex offender status has been WAIVED in order to facilitate her move to minimum security facility.

Here is her level and custody summary:

What stands out here is the custody level "OUT", which allows her to *leave* the minimum security campus for work assignments; much like Jeffrey Epstein was allowed to leave prison as part of the sweetheart deal he got from Alex Acosta that was penned by Alan Dershowitz.

I do not have information or communications about the decision or the reasons behind it, but that has been demanded in a Freedom of Information Act request filed by Democracy Forward. In a separate lawsuit, I have filed for Epstein materials including the training videos instructing FBI personnel on how to find and flag mentions of Donald Trump in the Epstein files.
